The Director, Shri Balaji Medical Foundation Raipur has applied for establishment of a Medical College at Raipur. On careful consideration of the proposal, the Government of Chhattisgarh has decided to issue an essentiality certificate to the applicant for the establishment of a Medical College with annual intake of **150 MBBS seats**.

It is Certified that :-

- (a) The applicant owns and manages a 436 bedded own hospital in Raipur which has been established in the year 2009.
- (b) It is desirable to establish a Medical College in the public interest.
- (c) Establishment of Medical College at Raipur by Director, Shri Balaji Medical Foundation Raipur is feasible.
- (d) Adequate clinical material as per National Medical Commission norms is available.

It is further certified that in case the applicant fails to create infrastructure for the Medical College as per National Medical Commission norms and fresh admissions are stopped by the National Medical Commission, the State Government shall take over the responsibility of the students already admitted in the college with the permission of the National Medical Commission.

- (e) The Shri Balaji Medical Foundation Raipur owns and possesses 10 (Ten) Acres of land in Dubey Colony, Mowa, Raipur City, Dist-Raipur (C.G.) on which non-agricultural use of land is permitted and a Medical College/Hospital can be established on it.
- (f) The building plan of the Medical Colleges has been approved by the competent authority, namely Joint Director town and Country planning & Commissioner Raipur Municipal Corporation designated by the State Government for such purposes only (Copy of the approval is enclosed)
- (g) The Hospital has been granted Completion Certificate and Medical College has been granted Building use Certificate by the competent authority, namely Joint Director town and Country planning & Town Planner nagar palika nigam designated by the State Government for such purposes on. (Copy of the Certificate is enclosed)

Conditions (e) (f) and (g) are applicable only for non-governmental applicants.

The Essentiality Certificate shall be valid for 3 years from the date of issue.
